Tuesday, July 10, 2018 - Regular Meeting

Meeting called to order by Supervisor Chandler at 7:30 p.m. All Board members were present.

Minutes of the June 12, 2018 regular meeting were read and approved with one correction on a motion by Peters supported by Bennett. Motion carried. Treasurer's report was read and approved on a motion by Chandler, supported by Peters. Motion carried.

Motion made by Bennett, supported by Chandler to pay the bills presented. Motion carried.

**Public comment held:** Brad Paquette introduced himself to the Board. He is running for the 78<sup>th</sup> District State Representative seat currently held by Dave Pagel, who has met terms limitation for that office.

Fire Department is planning an open house in August so the public has an opportunity to view the new fire truck that was delivered July 9<sup>th</sup>.

Maint. expense 101-441-985.000 \$1,200.00. Motion carried.
