Tuesday, August 14, 2018 - Regular Meeting

Meeting called to order by Supervisor Chandler at 7:32 p.m. Board members present were Chandler, Andres, and Bennett. Absent were Morgan and Peters.

Minutes of the July 10, 2018 regular meeting, July 10, 2018 Special Election Commission Meeting, and July 30, 2018 Special Meeting- Work Shop were read and approved with one correction in the minutes from July 30, 2018 Meeting on a motion by Chandler supported by Andres. Motion carried.

Ilene Fox asked if there was any ordinance that restricted target practice with in 500 feet from a homestead.

Motion made by Chandler, supported by Bennett to add Audit Review Presentation to agenda under old as presented. Aaron Stevens, SK&T Auditing stated the Township is in good financial standing. A copy of the audit report is available for viewing in the front office. Motion carried.

Motion made by Chandler, supported by Bennett to postpone HMA resurfacing on Hipps Hollow Road from Hillandale to Township line until next year as bid came in very expensive. Motion carried.

Motion made by Chandler, supported by Bennett to approve a 50/50 split on the cost of hoses for the new fire truck with the Sodus Firefighter's Association. The old hoses had leaks and new ones will be color coded for ease of use at future fires. The total cost of the hoses will be \$3,352.00. Motion carried.

Motion made by Bennett, supported by Chandler to purchase fittings for the water supply connections on the new fire truck at a cost of \$115.85. Motion carried.

Motion made by Chandler, supported by Andres to approved the Robert Muskopf Hardship Case, located at 3250 Townline Road, for 2018. Motion carried.

Motion made by Andres, supported by Chandler to approve the corrections made to the 2018 Annual Report of the Township as it had been presented. Motion carried.

Motion made by Chandler, to adjourn the meeting, supported by Bennett and so declared by Supervisor Chandler at 8:50 p.m.. Motion carried.
