Meeting called to order by Supervisor Chandler at 7:30 p.m. All Board members were present.

Brad Paquette touched base again with the Board he is running for the 78<sup>th</sup> District House of Representation for the State in November.

Jim Hnilo, from Ted Hartleb Insurance Agency presented to the Board the insurance proposal through VFIS, which is a combined policy that replaces our former AD&H and AD&D policies for our Board and Fire Department. The total savings to the Township would be \$695.00 yearly.
