Pledge of Allegiance

**Board members present**: Supervisor Chandler, Treasurer McCain, Clerk Andres, Trustee Bennett. **Approval of Agenda**: Motion made by Andres, supported by Chandler to approve the agenda as presented. Motion carried.

Approval of the Minutes: Motion made by Bennett, supported by Chandler to approve the minutes as presented. Motion carried.

Treasurer's Report: Accepted

Approval of the Bills:

General Fund 101: \$22,612.47 ARPA Fund 282: \$198,242.34 Cemetery Fund 209: \$3,074.39

Fire Fund 206: \$717.97 Public Works 592: \$1,698.58

Motion made by Andres, supported by Chandler to pay the bills as presented. Motion carried.

**Public comment held:** There were nine people in attendance. John Freehling wanted an update on 2076 Algonquin construction issue. Karen Morgan questioned why ARPA Fund not on the Treasurer report.

## Actions Approved:

Motion made by Chandler, supported by Bennett to approve the estimate from Ravitron Simply Connected for new phones and service for the Township Hall and Fire Department. The cost for hardware and install is around \$2400.00 and the monthly service contract will run around \$137 monthly. Motion carried.

Motion made by Andres, supported by Bennett to approve purchasing a new printer for the front office at the hall. The total cost staying at \$550.00 or less. Motion carried.

Resolution #24-2023 to adopt and use the 1997 Uniform Building Fee Schedule for building permits and fees in the Township of Sodus, motion was made by Chandler, supported by Bennett. The new building fee schedule will take effect January 1, 2024. Roll call: Chandler-yes, Andres-yes, Bennett-yes, McCain-yes. Motion carried.

Motion made by Chandler, supported by Bennett to continue researching businesses that work with municipalities on Township Master Plans and Park Plans. The Board will then revisit the development of a new master plan at the December meeting. Motion carried.

Motion made by Chandler, supported by Andres to approve the BS&A Tax Service Agreement with the County for the next two tax seasons starting with 2024-25. The cost will be \$2100 plus any increase in BS&A. Motion carried.

Motin made by Andres, supported by Chandler to use the remaining balance of the ARPA monies to pay Kalin Construction Co. for the parking lots and cemetery driveways and any remaining balance be paid from the General Fund. Motion carried.

Reports and Communications: Fire Chief, Everett Steinke, reported that he accepted on behave of the fire department a \$200.00 check from Moose Lodge and twelve "Tommy Moose" stuffed animals for children involved in any first responder calls or fires. The fire department also received carbon monoxide and smoke alarms to distribute to families in need of them. He also stated the air packs maybe in by the end of the year and compressor not till February of next year.

**Board and Staff Comments:** Treasurer McCain addressed the Board with concerns of professionalism in the office and that a police report has been filed with State Police concerning a missing tax payment.

Adjournment: Motion made by Chandler to adjourn the meeting and supported by Andres. Meeting closed at 9:14pm. Motion carried.
