Motion made by Chandler, supported by Peters to approve the distribution of \$25,000.00 from the General Fund to the Cemetery Fund as a transfer out/transfer in for the operating budget of the Cemetery Fund for FY 2024-2025. Motion made by Andres, supported by Chandler to approve the letter of support for the M-139 Rehabilitation Project funded by a Rural or INFRA Grant that we endorse the coordination with TwinCATS on the project. The only portion of M-139 that is in Sodus Township starts at the former Country Kitchen restaurant and just beyond I-94 on off ramps. Motion carried. 4:0
