Tuesday, December 8, 2020 -Regular Meeting

Meeting called to order by Supervisor Chandler at 7:34 p.m.. All members were present.

Minutes of the November 10, 2020 regular meeting meeting were read and approved with two corrections on a motion by Chandler, supported by Peters. Motion carried.

Treasurer's report was not available to review.

Motion made by Chandler, supported by Peters to pay the bills as presented. Motion carried.

Motion made by Andres, supported by Chandler to approve the purchase of a new sign for the Fire Department. The style chose was #4 gray background. The cost will be \$754.00 plus installation cost. Motion carried.

Motion made by Chandler, supported by Peters to allow one authorized signature on the checks to pay the bills this month of December 2020. Motion carried.

Motion made by Chandler, supported by Bennett to approve Supervisor Chandler's appointment of Jerry Grajauskis to another three year term on the Zoning Board of Appeals and also David Schilke, Ilene Fox, and Clarke Allen to another two year term on the Board of Review. Oaths will be taken by December 31, 2020. Motion carried.

Motion made by Andres, supported by Chandler to approve the appointment of Victoria Chandler as deputy clerk for Clerk Andres and approve her as an authorized signer for the Township. Terry McCain, Treasurer, as an authorized signer for the Township. Treasurer McCain appointed Lori Wilcox as her deputy treasurer and she will be added as an authorized signer. Also approved removing former treasurer Karen Morgan and deputy treasurer Kenneth Morgan and deputy clerk Johnny Case as authorized signers from the Township accounts. Motion made.

Motion made by Chandler, supported by McCain to accept Johnny Cases resignation as Township secretary. Many thanks go out to Johnny for her many years of dedicated service to the Township. (4 aye 1 nay) Motion carried.

Motion made by Chandler, supported by Andres to place an ad in The Journal Era and/or Herald Palladium to fill the vacancy of Township secretary position. Motion carried.

Motion made by Chandler, supported Andres to add Terry McCain on the credit card account as an authorized user. Motion carried.
