TOWNSHIP BOARD MEETING

Tuesday, April 12, 2022 -Regular Meeting

Meeting called to order by Supervisor Chandler at 7:00 p.m. All members present except Trustee Ken Peters.

Minutes of the March 29, 2022, public budget hearing and special regular meeting were read and approved on a motion by Chandler, supported by Bennett. Motion carried.

Treasurer's report was accepted.

Bills presented: General Fund 101: \$29,107.64 Road Fund 204: \$0.00 Fire Fund 206: \$7,285.96
Cemetery Fund 209: \$3,526.08 Public Works Fund 592: \$0.00

Motion made by Bennett, supported by Chandler to pay the bills as presented. Motion carried.

Public comment held: Joe Killey, Angelika Hagar, Joe Taylor, and Everett Steinke were in attendance.

Fire Chief updated the Board on the fire department and a reminder of the pancake breakfast that will be held on April 24, 2022, 7am to 12:30pm.

Motion made by Chandler, supported by Bennett to add three items to the agenda as presented. Motion carried.

Motion made by Andres, supported by Bennett to decline the road improvement bid for Hartman Road between Hillandale Road and Pipestone Road. The bids approved come back with material increases from the Road Department. By eliminating the Hartman Road project till next year, the Township will stay in budget with the approved projects. Motion carried.

Motion made by Chandler, supported by Bennett to accept the written resignation of Jacob LaVanway as Captain of the Sodus Fire Department. Motion carried.

Motion made by Chandler, supported by Bennett to approve paying the bill for \$320.00 for 8 firefighters receiving CPR training by Pro Safety Innovations on April 5, 2022. Motion carried.

Motion made by McCain, supported by Chandler to add an additional item to the agenda as presented. Motion carried.

Motion made by McCain, supported by Andres to approve collecting the LMC taxes in the summer 2022 tax season. Motion carried.

Motion made by Bennett, supported by Chandler to approve the 2022-23 contract with David Cochran, as the Township cemetery grounds maintenance and cremains sexton. Motion carried.

Contract from Mark Ferry as grave excavator and burial sexton did not get turned in time so Board will review it at next months meeting.

Motion made by Bennett, supported by Chandler to approve changing the May regular meeting date and time from May 10, 2022, 7pm to May 3, 2022, 6pm. This was done to accommodate meeting with Brownfield authorities over the Speedway project tax exemption application. Motion carried.

Motion made by chandler, supported by Bennett to approve the Township Clerk to pay any bills that are received after the May 3rd meeting, to avoid late fees. Motion carried.
